

Privacy Policy

1. Introduction

2. Information We Collect

- **International Transfers:** If we transfer your data outside the European Economic Area (EEA), we ensure it is protected by appropriate safeguards.

6. Data Retention

We retain your personal data for as long as necessary to fulfill the purposes for which it was collected, or as required by law. This includes retaining information to comply with our legal obligations, resolve disputes, and enforce our agreements.

7. Your Rights

Under the GDPR, you have the following rights regarding your personal data:

- **Right to Object:** Object to the processing of your data for direct marketing or on grounds related to your particular situation.
